Gift Aid Declaration

There is no need to sign a Gift Aid declaration each year, as your Declaration remains active unless you cancel it. If, however, you have not previously signed a Declaration, please consider doing so. The ESO could claim Gift Aid from the subscriptions and donations you have paid over the past 6 years. If in any doubt as to whether you have previously signed a Declaration, please do so.

Banker's Order

We ask that, if you have not already done so, you complete the Banker's Order section of the form. This will reduce the administrative burden for the Membership Secretary and the Treasurer, and ensure that your subscriptions are paid promptly and automatically each year.

Gift Aid Declaration

The Edinburgh Society of Organists is able to claim a tax refund on any subscriptions and donations paid to the Society, where we hold a Gift Aid declaration signed by the donor. For a £12 annual subscription, this adds £3.36 each year to the Society's income, at no additional cost to yourself.

So long as you expect to pay at least £3.36 income tax or capital gains tax in the year, you are entitled to sign a Gift Aid declaration. We ask that you consider doing this - around 70% of ESO members have already done so.
